## ORDINANCE OF THE GOVERNMENT OF THE RUSSIAN FEDERATION

No. 362 of April 23, 2013

## **ON SPECIFIC FEATURES OF TECHNICAL REGULATION PERTAINING TO DEVELOPING** AND ESTABLISHING BY THE STATE CUSTOMERS, FEDERAL **EXECUTIVE BODIES AUTHORIZED IN THE FIELD OF** STATE ADMINISTRATION OF ATOMIC ENERGY USE AND STATE SAFETY REGULATION IN ATOMIC ENERGY USE AND THE STATE ATOMIC ENERGY CORPORATION "ROSATOM" THE MANDATORY **REQUIREMENTS FOR THE PRODUCTS** SUBJECT TO REQUIREMENTS RELATED TO SAFETY ASSURANCE IN THE FIELD OF ATOMIC ENERGY USE, AS WELL AS THE PROCESSES OF DESIGNING (INCLUDING SURVEY), **PRODUCTION, CONSTRUCTION, INSTALLATION,** PRE-COMMISSIONING, OPERATION, STORATE, TRANSPORTATION, MARKETING, DISPOSAL, REMOVAL AND BURIAL **OF THE STATED PRODUCTS**

Pursuant to Paragraph 2 of Article 5 of the Federal Law "On Technical Regulation", the Government of the Russian Federation Ordinances:

1. To establish that:

a) the state customers, federal executive bodies authorized in the field of state administration of atomic energy use and state safety regulation in atomic energy use and the State Atomic Energy Corporation "Rosatom" are entitled to develop mandatory requirements, insofar they are not at variance with federal codes and regulations, in respect to the products that are used at nuclear facilities and covered by safety assurance requirements in the field of atomic energy use (hereinafter referred to as the products), as well as the processes of designing (including survey), production, construction, installation, pre-commissioning, operation, storage, transportation, disposal, removal and burial of the products (hereinafter referred to as the processes);

b) the regulatory legislative acts, which establish requirements for the safe use of atomic energy, are used as the documents establishing mandatory requirements in respect of products and processes; the regulatory legislative acts are developed, approved and enforced according to the laws of the Russian Federation "On Atomic Energy Use", technical regulations, technical documentation (design, engineering, process and operation documentation) for the products or for the products and practices, documents in the sphere of standardization in respect of the products and practices;

c) alongside with the mandatory requirements in respect of products and processes, which are established in the documents envisaged by item b) of the present paragraph,

mandatory requirements in respect of products and processes can be established by state customers, federal executive bodies authorized in the field of state administration of atomic energy use and state safety regulation in atomic energy use, as well as by the State Atomic Energy Corporation "Rosatom" in government contracts (agreements).

2. Federal executive bodies authorized in the field of state administration of atomic energy use and safety regulation in atomic energy use as well as the State Atomic Energy Corporation "Rosatom" post on their official sites in the information and telecommunications network "Internet" the documents (parts of documents) envisaged by item b) of paragraph 1 of the present Ordinance establishing the mandatory requirements pertaining to the products and processes taking into account the limitations determined as per legislation of the Russian Federation on the state and other legally protected secret.
