## On Approval of Regulation for Qualifying Legal Entity as Technical Support Organization for Authorized State Safety Regulatory Body in the Use of Atomic Energy

In accordance with Article 37.1 of the Federal Law On Atomic Energy Use the Government of the Russian Federation Ordinances the following:

To approve the attached Regulation for Qualifying Legal Entity as Technical Support Organization for Authorized State Safety Regulatory Body in the Use of Atomic Energy.

## Regulation

## for Qualifying Legal Entity as Technical Support Organization for Authorized State Safety Regulatory Body in Atomic Energy Use

1. This Regulation establishes the procedure of qualifying a legal entity as a technical support organization for an authorized state safety regulatory body in atomic energy use (hereinafter referred to as the technical support organization).

2. The Federal Environmental, Industrial and Nuclear Supervision Service, being an authorized authority for the state safety regulation in the field of use of atomic energy (hereinafter referred to as the authorized authority), is in charge of qualifying a legal entity as a technical support organization.

3. The legal entity can be qualified as the technical support organization, provided it complies with the following criteria:

a) the authorized authority exercises the powers and authority of legal entity founder;

b) the legal entity has a license for safety review (safety analysis review) of nuclear facilities and (or) kinds of activities in the field of atomic energy use;

c) the legal entity performs research works, aimed at scientific and technical assurance of state regulation of safety in atomic energy use ;

d) the legal entity carries out research, testing, reviews and (or) other types of the assessment of safety of nuclear facilities and (or) kinds of activities in the field of atomic energy use, envisaged by the legislation of the Russian Federation in the field of atomic energy use;

e) the legal entity is a member of international organizations in the field of atomic energy use, or participates in their activities.

4. To be qualified as the technical support organization, the legal entity submits an application to the authorized authority, with the indication of its full and abbreviated (if

any) name, as well as data, confirming its compliance with the criteria established by item 3 of the given Regulation, with attached documents, confirming the compliance with the criteria, (hereinafter referred to as the application).

The applicant submits the application directly to the authorized authority, or forwards it by registered mail with notification on delivery.

The applicant has the right to send the application in electronic version by means of informational and telecommunication network.

5. The authorized authority determines whether the applicant meets the criteria, established by item 3 of the given Regulation, within 15 working days upon receipt of the application.

If the applicant meets the criteria, the authorized authority makes a decision on qualifying the legal entity as the technical support organization, upon which the authorized authority draws up an act.

6. Notification on qualifying the legal entity as the technical support organization is sent to the applicant by registered mail with notification on delivery within 15 working days after the decision on qualification is made, or is handed to applicant representative under signed receipt and only after a document, confirming that the representative has the right to receive the notification, is submitted.

7. In case the applicant does not meet all the criteria, established by item 3 of the given Regulation, the authorized authority makes a decision to refuse qualifying the legal entity as the technical support organization, and draws up an act upon it.

8. Notification on refusal to qualify the legal entity as the technical support organization, including grounded substantiation of reasons for the refusal, is forwarded to the applicant by the authorized authority by means of registered mail with notification on delivery within 3 working days after the relevant decision is made.
